## **Re: Public Records Requests Dated December 22, 2003**

Dear Ms. Choe:

We are still waiting for all the documents required by the public records request from Jason Mercier of the Evergreen Freedom Foundation regarding the Boeing contract. The initial request was by phone to the Governor's office on December 19, 2003, and then in writing on December 22, 2003. Follow up requests were written on January 9, 2004 and January 19, 2004. When we requested a copy of the Boeing agreement, we believed that all documents would be provided. We did not anticipate that, to receive all documents referenced in the agreement, we would have to ask for each and every referenced section of the agreement. Please furnish the following documents by 5 p.m. tomorrow, January 27, 2004 or indicate the reasons why these documents have been unavailable to this point and when they will be available.

1. "Certain response to the Site Application Questionnaire for Project Olympus, containing thirty-eight (38) pages and additional referenced attachments." (Recital B)
2. "Certain Project Olympus Legal Questionnaire Washington State Response dated October 3, 2003, containing forty-four (44) pages and appendices." (Recital B)
3. "Certain Correspondence restating the State's commitments to McCallum Sweeney Consulting, Inc. dated November 10, 2003, containing 12 pages including appendices as set forth in Schedules 1-3." (Recital B)
4. A copy of the "Governor's Executive Order or clear directive," which is required by Section 7.3. "To be issued to each of the WTECB, ESD, CTC and CTED identifying the role and responsibility of the Workforce Development Coordinator and the responsibilities of each agency for enabling the Workforce Development Coordinator to be effective, including funding, communications, expectations and management accountability." Please note that this was required to be issued "concurrently with the execution of" the Agreement. (Section 7.3).
5. A copy of all authorizing resolutions in accordance with Section 10.2 (Exhibit F). The document you sent was blank—not redacted, but blank.
7. A copy of the opinions of Counsel (Exhibit G). The document you sent was blank—not redacted.

8. A copy of Schedule 1: Site application questionnaire for Project Olympus. The document you sent was blank—not redacted. Please confirm if this is the same as #1 above.

9. A copy of Schedule 2: Project Olympus Legal Questionnaire – Washington State Response. The document you sent was blank – not redacted. Please confirm if this is the same as #2 above.

10. Restatement of commitments dated November 10, 2003. The document you sent was blank— not redacted. Please confirm if this is the same as #3 above.

Ms. Choe, the Governor signed this agreement more than five weeks ago. We need these documents immediately as allowed by law.

Please call my office at 956-3482, and we will pick them up.
